ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Al Fatima Educational Society, Plot No. 4010, Vill. - Gonpura Lahyarchak, Street No. Alampur, PO. - Gonpura, Tehsil/Taluka - Phulwarisharif, Town/City - Patna, Dist - Patna, Bihar - 801505 has submitted an application (Code No.ERCAPP1224) to the Eastern Regional Committee, NCTE for grant of recognition for conducting B.Ed Course with an annual intake of 100 (one hundred) by online on (mm/dd/yyyy) 9/30/2011 and hard copy of application submitted on (mm/dd/yyyy) 10/24/2011.

2. WHEREAS, as per the decision of ERC in its 153 meeting held on 9-10 April 2013 recognition order was issued to Al Fatima Educational Society, Plot No. 4010, Vill. - Gonpura Lahyarchak, Street No. Alampur, PO. - Gonpura, Tehsil/Taluka - Phulwarisharif, Town/City - Patna, Dist. - Patna, Bihar - 801505 for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (one hundred) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009, vide ERC order No. ERC/7-153.6.10/NCTE/B.Ed./2013/17657 dated 17-Apr-13.

3. AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 19285/13 in the Hon'ble Supreme Court of India against the said recognition order dated 17-Apr-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.

4. AND WHEREAS the Eastern Regional Committee in its 158 Meeting held on 23-24 July 2013 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 6/26/2013 and decided that revised recognition order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Al Fatima Educational Society, Plot No. 4010, Vill. - Gonpura Lahyarchak, Street No. Alampur, PO. - Gonpura, Tehsil/Taluka - Phulwarisharif, Town/City - Patna, Dist. - Patna, Bihar - 801505 for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (one hundred) from the academic session 2013-2014 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

5. The recognition is subject to fulfillment of the following:

 - b. Land and Building Particulars
 - c. Staff Profile
 - d. Recognition letter
 - e. Information for having fulfilled the norms & standard and other required conditions.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
